Role of the Collaborative to End Human Trafficking:

The Collaborative to End Human Trafficking is the backbone organization of Greater Cleveland Coordinated Response to End Human Trafficking. Staff of the Collaborative supports the coordinated response by performing the following functions:

- **Technical Assistance & Training:** Provide training and technical assistance to overcome obstacles and increase the community's ability to identify and address human trafficking.
 - **Facilitate:** Support members to move forward together to achieve their shared purpose. Facilitation ranges from helping GCCRHT and individual members identify how to align their actions to support those strategies and goals.
 - **Coordinate & Catalyze:** Assist members in coordinating their actions to maximize outcomes and catalyze new, innovative actions identified by GCCRHT.
 - **Data:** Collect, analyze, and distribute data to help members improve outcomes.
 - **Communicate:** Enhance communication between members and the greater group through creating connections, disseminating information, and collaboration.
 - **Advocate:** Champion policies that advance the purpose of the coordinated response, including creating a venue for survivor voice/guidance and fostering an environment supportive of diversity, equity, and inclusion.
